

Budget Overview for the 2023-24 School Year




This chart shows the total general purpose revenue Coastal Grove Charter expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Coastal Grove Charter is \$3,631,022, of which \$2,764,266 is Local Control Funding Formula (LCFF), \$497,941 is other state funds, \$202,752 is local funds, and \$166,063 is federal funds. Of the \$2,764,266 in LCFF Funds, \$348,493 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


These expenditures include rent, grounds, janitorial services, business services, and tech services. Also included are costs for unanticipated outside support services including HCOE, Remi Vista, Multiplicity, additional time for staff and office support. Office staff, benefits and health and welfare.

Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Coastal Grove Charter is projecting it will receive \$348,493 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

Coastal Grove Charter School, a California nonprofit public benefit corporation with 501(c)(3) tax-exempt status, is authorized by Arcata Elementary School District. We have approximately 239 students and our free and reduced-price meal percentage is approximately 56%. The school offers an integrated method of Waldorf education which fosters a life-long love of learning by educating the whole child: head, heart and hands. By challenging the head, inspiring the heart, and motivating the hands, the school educates children in a K-8 setting. We offer a classroom-based and homeschool program. Our small group setting enriches the imagination, creativity, academic excellence, and social responsibility. Educated students will emerge capable of self-expression, effective communication, problem solving and critical thinking, and with a global consciousness and ability to succeed amidst the challenges of our changing world. This integrated approach balances artistic, academic, and practical work to foster a life-long love of learning. Following the metrics is not applicable because we are a K-8 school with no EL students this year, and we do not have a high school. Here at Coastal Grove we believe that all students can achieve their fullest potential through a supportive and a strong school community that works together with families. Coastal Grove is in a strong position to continue meeting our goals as we prepare Coastal Grove students for success.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

High-quality instruction and curriculum was delivered based on Waldorf pedagogy and state standards with a broad course of study including enrichment and healthy living educational components. In spite of the pandemic, and the resulting loss of in-person seat time, students continued to be excited to learn, especially after we began our hybrid program in the spring. Our students were engaged in learning, and our supports, which promoted positive behavior and wellness, resulted in high attendance rates. By involving parents in school programs, whether in person or via distance learning, students had greater support and families had greater awareness of the challenges we faced this

year and the programs we offered, as well as how to support their students.

Coastal Grove achieved the following successes:

- Average student-teacher ratio is 20:1.
- Personalized support to ensure students are receiving a well-rounded education that will allow them to achieve academic and life success in high school and beyond.
- Strong parent/guardian and community investment, and is supported by local businesses and organizations.
- Students and families also support local organizations through community service.
- There is a waitlist for the school because of its long and strong track record of serving Arcata students.

In addition:

- Coastal Grove provides a range of professional development opportunities for teachers and staff. Professional Development opportunities are paramount at Coastal Grove. All staff members have completed required trainings, including all mandated and legally required workshops, as well as Waldorf trainings and coursework. Coastal Grove's teachers work collaboratively to best serve the students at Coastal Grove and through learning together in focused trainings. These trainings have included and will continue to include: suicide prevention and awareness, approaches for reducing suspension, instructional strategies to promote academic engagement, and classroom management. Teachers are offered professional development opportunities to ensure application of new concepts and successful implementation of new skills. In addition, all teachers attend professional development during the summer, and new teachers attend additional days of new teacher orientation prior to the start of the school year. Most importantly, Coastal Grove schedules staff meetings throughout the school year to examine a variety of internal and external assessments to determine progress and areas of opportunities. These assessments include: CAASP, interim main lesson block assessment, curriculum embedded assessments, attendance, behavior and emotional support. During these data analysis meeting sessions, the administrator, teachers, and staff analyze their students' assessment data to identify common areas of opportunities and success. Teachers modify lesson plans accordingly, to focus on the areas of opportunity and build on the success. Administration assesses the impact of these data analysis sessions by conducting classroom observations, and by providing meaningful feedback to teachers and staff. Teachers are encouraged to attend workshops and seminars throughout the year. Many staff members also participate in a variety of local conferences and workshops.
- Coastal Grove has established an effective communication and student record system. SchoolWise is a powerful, easy-to-use
 communication tool which enables students, parents/guardians, teachers, and administrators to work together to improve student
 achievement. With SchoolWise, teachers and administrators can send student-specific and general messages home whenever
 necessary via the telephone or via electronic mail. Messages sent through a general broadcast system can include messages
 concerning school events and emergencies, or individual communications sent to each parent/guardian concerning their child's
 school experience and attendance.
- Coastal Grove has a 20-year history of serving students in and around Arcata, including pupils of all ethnicities and special education backgrounds, which is reflective of the general population residing within the jurisdiction of Arcata Elementary School District. Coastal Grove follows an open enrollment period each year, and after the applications are counted to determine whether any grade level has received more applications than availability, admission is determined by a lottery process to determine

- admission for the impacted grade level. Records of the lottery are kept on file to ensure appropriate procedures were implemented, and are available for inspection.
- Coastal Grove's enrollment rate has remained constant over the last four years of the charter term with an average of 230 students enrolled each year.
- Coastal Grove's attendance rate has remained constant over the last four years of the charter term with an average daily attendance rate of 94.6% each year.

The above table summarizing Coastal Grove's schoolwide Dashboard performance demonstrates that Coastal Grove met the standard for all local indicators in 2018 and 2019. Of the four statewide indicators reported in 2018 and 2019, Coastal Grove met or exceeded the State's performance level on two of those levels in 2019 after exceeding them on all but one measure in 2018. In particular, in 2019, Coastal Grove earned the highest possible performance level – blue on the suspension rate indicator, and the second-highest level – green – in English Language Arts.

Coastal Grove has identified areas that need improvement based on a review of Dashboard and local data. Coastal Grove is committed to goals that address the needs of the students and families we serve. Academically, we showed a yellow in Math, indicating a 10.1 point decline from the previous year.

One current goal is to improve the academic achievement of all students, with a focus on Math. The steps that will be taken to address this area of achievement are identified in the goals, actions, and services.

In addition, we will strive to decrease Chronic Absenteeism to 5% or lower, from the rate of 16.7% in 2019. In 2020-21, attendance was negatively impacted by distance learning and the need to phase in our in-person learning opportunities.

In addition, Coastal Grove recognizes the importance of social emotional well-being of students and maintaining an active partnership with parents/guardians, staff, teachers, and community members. We will develop and enhance opportunities in this area. These goals reflect Coastal Grove's commitment to student mental health and well-being and an active school community.

LCAP Highlights

The purpose of this Local Control Accountability Plan (LCAP) is to address the School Plan for Student Achievement (SPSA) for Coastal Grove which is the Schoolwide Program; herein referred to as the LCAP. Coastal Grove's plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP to address these requirements include focusing on four goals: 1) Deliver high quality instruction and curriculum based on Waldorf pedagogy and state standards. 2) Offer a broad course of study which includes enrichment and healthy living. 3) Engage students in learning and encourage positive behavior to continue high attendance rates and low referral rates. 4) Involve parents in school programs and ensure family awareness of support services for students.

The needs assessment process included meeting parents, guardians, classified staff, teachers, and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the Charter Council, PTO and staff meetings. Each group will meet regularly to inform the process. Parents, community members, classified staff, certificated staff, and an administrator make up each of these groups. These groups discuss academic performance, supplemental services and areas to make improvements as part of the School Plan included in the LCAP conversations in meetings held throughout the year. The teachers, staff, and administrator actively participate in the decision-making process throughout the year and during workshops. Our decision-making process takes into account the needs of Coastal Grove based on student achievement data to include CAASP, cumulative assessments, discipline, attendance, and student demographic data. This student achievement data and student demographic data will be used as a basis for making decisions about the use of any supplemental federal funds and the development of programs and processes for basic core services.

Each goal includes actions and services that address the needs of all students and significant subgroups. They include evidence-based strategies that provide opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards. The LCAP 2021-24 was developed with input from key stakeholders including parents/guardians, staff, teachers, administrators, and community members. Coastal Grove will keep the previous four goals in order to address the specific areas where growth is needed.

Following the ongoing PTO, staff and Charter Council meetings, the administrative analysis included their feedback in developing salient points in the LCAP. The most important areas of priority identified were academic achievement, professional development, full-time, inperson instruction, student social emotional health and well-being, and opportunities for parents/guardians, teachers, staff, and community members to support student high school readiness.

Our annual parent survey is distributed every spring. It is attached to our weekly newsletter, The Friday Flyer. The Friday Flyer goes out via email. It is also available in hard copy in the office. An LCAP survey was distributed to parents, staff, and students to gather creative comments and ideas. This year LCAP data was gathered through two parent surveys and one student survey, parent conferences and parent class meetings, as well as zoom meetings, in-person meetings and observations.

Based on the stakeholder feedback received, the goals and actions were developed to address academic achievement through professional development, full-time, in-person instruction, student social emotional health and well-being, and opportunities for parents/guardians, teachers, staff, and community members to support students.

We conducted ongoing Restorative Practices staff development trainings, Waldorf trainings and a large number of teachers are participating in the 3 year Waldorf training for educators to improve teacher effectiveness. We continued EDI work throughout the year. We provided extra aids for classrooms, added additional personnel for reading support, and provided additional extracurricular activities including new clubs, tutoring, and a full sports program to address Academic Interventions. We did experience another year of high absenteeism, and are looking to address this substantially.

We over budgeted for our Supplemental Concentration Grant, so expenditures were shifted to Title 1 and ELOG.

Our SEL work, while important, did not result in improved attendance. Our math program is building student confidence in math, and teacher trainings are creating a more comprehensive academic program. Academic assessments show a measurable growth in student reading scores for students who have been struggling and have participated in our reading RTI program.

We are not changing any goals, however we will be focusing on specific aspects of each goal. In math, we will be focused on differentiated learning, for assessments, we are incorporating specific reading assessments throughout the grades. We need to improve our absenteeism and will be implementing a whole school approach addressing parent education, student positive reinforcement, and additional outreach.

By the end of this year there will be 4 additional fully trained teachers. Food services provided two free healthy home-cooked meals to every student daily. Our offerings included local foods to support local farmers. Our aftercare program collaborated with 4-H to offer a rotation of activities. Aftercare was a success including some students attending the intersession days.

We have been monitoring the rates of suspension, attendance, and chronic absenteeism. This year was difficult as changes in vaccine laws affected many of our families. Additionally we still had Covid circulating and some families reporting high levels of anxiety in students.

In the development of each action provided to Coastal Grove schoolwide, the needs of English Learners and socioeconomically disadvantaged students were considered first as each action was analyzed to determine if the focus was specifically for these students or if these students should be prioritized to receive the services prior to all other students receiving the services. The LCFF regulations dictate that Coastal Grove provide increased and improved services for these students that are above and beyond services provided to all students during the school year. With this plan, the LCAP 2021-22 estimated the amount of supplemental and concentration grant funding to be \$223,735 which is proportionately 11.54% to increase or improve services.

The contributing actions are:

Staffing to support the academic and social emotional well-being of socioeconomically disadvantaged students and English Learners.

Using the calculation tool provided by the state, Coastal Grove has calculated that it will receive \$348,493 in Supplemental and/or Concentration funding under the Local Control Funding Formula (LCFF). The proportionality percentage to increase or improve services has been calculated at 14.82%. Coastal Grove has demonstrated that it has met the 14.82% proportionality percentage by planning to expend all the supplemental and/or concentration funds on actions or services for English Learners and socioeconomically disadvantaged students.

A description of how services for foster youth, English learners, and low-income students are being increased or improved by the percentage required.

Any supplemental funds, actions, and services provide additional layers of service for socioeconomically disadvantaged students by providing additional support and training for teachers specifically designed to focus on the needs of the unduplicated student groups, intervention and enrichment activities and resources for these students, and additional personnel to support the continued and regular progress of students.

All students will be provided with services for homework support and after school support clubs. However, our reading intervention program and special subjects both contribute to provide learning opportunities in the arts and other special subjects in an environment serving English Learners and socioeconomically disadvantaged students. The special subject program contributes greatly to providing these learning opportunities. We also offer an exceptional nutrition program and reading support program. English Learner and socioeconomically disadvantaged students receive a greater percentage of services than other students, due to receiving more attention from the teachers during extended learning time and after school support. Teachers will pull students in need of additional support for small groups and one-on-one support when a credentialed special subject teacher is instructing the class. Qualitatively, the expenditure of supplemental funds for more trained personnel targets primarily unduplicated students, providing services above and beyond those provided for all students, and quantitatively, the additional services will be provided for unduplicated students with no additional costs.

A description of the plan for how the additional concentration grant add-on funding identified above will be used to increase the number of staff providing direct services to students at schools that have a high concentration (above 55 percent) of foster youth, English learners, and low-income students, as applicable.

This funding provides for increased staffing in academic and social emotional learning for students. We have the ability to retain special subject teachers, and reading intervention teachers.

(Measurable Outcomes [Effective In])

- Total Percentage to Increase or Improve Services for the Coming School Year: This percentage will not be entered; it is calculated based on the Projected Percentage to Increase or Improve Services for the Coming School Year and the LCFF Carryover —

Percentage. This is the percentage by which the LEA must increase or improve services for unduplicated pupils as compared to the services provided to all students in the coming LCAP year.
